From the office of RKA...

Here at the co-op, we are constantly working on upgrading our systems to be "cyber-safe" but we cannot do it without all employees doing their parts by being cautious of suspicious e-mails, odd websites, etc. If you have any questions about cyber security or what you can do to protect yourself, give me a call. I have tons of notes on it!




And a Happy New Years From Wheatland REA! We will be closed on December 25, 2017 and January 1, 2018.
