

It is a beautiful spring day outside as I write this! 80 degrees and no breeze! I know, enjoy it while we can!

Lots of things are happening around the REA as we are getting in full swing of construction season. We have been replacing about five miles of line along Slater Road for the last several weeks. This line should be completed very soon, and we will start replacing poles in other areas that are failing. By the time you get this issue of WREN, we will have our tree trimmers here as well as our pole testers. We recently completed the Finnerty Substation at the tank farm near Guernsey to feed a new pumpstation, and we are waiting to hear on the potential of another pumpstation on the north end of the system. In addition, we continue to build new services, all while continuing with the regular maintenance. All of this keeps everyone very busy!



Another project that we recently heard about, which does not directly involve Wheatland REA, but will affect some of our members, is a new transmission line being proposed by Black Hills Energy. This line project is called "Ready Wyoming". This will be a transmission

line about 260 miles in length, running from Rapid City to Cheyenne, passing by Glenrock. Black Hills has sent letters to our members along the proposed route. Overall, the construction will start sometime in 2023 (hard to believe that is next year!) and then will be completed in 2025. At this time, we have requested information regarding the proposed route through our area. We are not directly involved in the project but we want to be informed should you be curious. If you have questions on the project, please visit us or give us a call. If we don't have the information, we will do our best to find out what we can!

We continue to deal with supply chain issues. Cost and availability are a nightmare! I don't need to tell you what fuel costs have done and that everything else is following suit. I just heard this morning that, at this time, 40-foot poles, one of our main pole sizes, are not available at this time. We ordered a new digger truck for delivery in late 2021, it was then moved to mid-2022 and we are now told that it will not be delivered until early 2023. This will be more than a year late! It used to be that if a supplier missed a delivery by this much, we would tell them that we would get it somewhere else. We can no longer take such a stand because all suppliers are facing the same issues. While this example is a large truck, it's similar to our equipment and supplies at an increased cost. We are in a period of *you don't get what you need, you don't get it when you need it, and you pay enormously increased costs.* A perfect storm for poor customer service. We are doing our best to stay ahead of these issues; however, it is becoming more difficult!

Unfortunately, these increased costs have put a burden on everything we do, and it has become necessary to look at our rates. Nothing is planned at this time, but we are looking at it. When the need arises to adjust rates, we will keep you informed which will likely be toward the end of the year.

On a positive note, Flag Day is June 14th. This is a very special day to show your love and support of this great nation by flying the flag. I always enjoy seeing the displays of flags around town and feeling the patriotism that abounds in this great state. I love seeing the colors and thank you to everyone that flies their flag!

As always, it is a pleasure to serve the fantastic members of Wheatland REA and work with such a dedicated group of employees that love their jobs and love to serve you. I will tell you that this is nationwide as I received an invoice in the mail a couple of weeks ago and it was in a brown envelope also. This conundrum is continuing to affect us here not only budget wise but also the cash flow. We are still seeing a 30%-40% increase in materials and supplies. As management, we try hard to avoid rate increases but it is a conversation that we must have especially during this inflationary period that we are having right now. Of course, we will keep you posted about the increase of rates.

On the family home front, we are staying busy fishing and enjoying the great weather we are having. Before the fishing extravaganza really got heated, my hubby headed to Canada for a week for geese hunting. Fortunately, no new furry friend was brought home this time!!! I am thinking that it was difficult enough to get himself back and forth over the border, let alone a four-legged animal! LOL! But I am loving the pup that was brought home from his last trip.
